#### ❖ Fire Chief's Report

Alan Wright read fire report for March 2021.

Supervisor Report – Roads – Gave us a list of all the lake roads and had them rated from one (good) to five (the worst). Remodel of office is done.

This is to ensure that Spencer Township is meeting minimum assessing requirements or may have Kent County take over assessing.
