1. **Supervisor Knapp called the meeting to order.**

 - ❖ **Fire Chief's Report**
Alan Wright read fire report for April 2021.

 - c. Kent County foreclosed properties. All board members reviewed both properties. Wood motioned that Spencer Township does not have any interested in either one of the mentioned properties, Lange seconded. All yes. Zero No.
