Fire Chief's Report

Captain Rick Haner read fire report for July 2022.

- Supervisor Report Betsy our tech person and her family is in need of our thoughts and prayers. Update on roads – Rooksby Road is ongoing and 22 Mile is waiting for Montcalm County. Cemetery stones are being replaced that are so old that they can no longer read them. Five were done this year by Jeff with an at cost price of stones from Hurst & Pattern Monument. Catholic cemetery on 16 Mile is asking for us to cover flags for veterans and because they are a private cemetery we cannot just supply them with flags. The church is being split off from the cemetery and being sold.
- Planning & Zoning Commission Meeting August 10, 2022 They reviewed a resolution on solar power farms and will address it further at next meeting. The Master plan will remain the same, except to exchange out the 2020 census data. They sent it to the township board to approve with that one change. Wood made a motion to approve and Lange supported. Motion carried.
- Library Feeding America is done with 250 meals. Zoo event was still held in between rain storms.
 Finished reading program with 150 people participating.
